



## DIY CHRISTMAS SALE – DO IT YOURSELF & SAVE!

### TERMS & CONDITIONS

- The Alstonville Tiles & Floorcoverings, 'DIY Christmas Sale – Do it yourself & Save!' sales promotion, will from here afterwards be referred to as 'the promotion', throughout the following terms and conditions.
- The Alstonville Tiles & Floorcoverings, 'DIY Christmas Sale' the promotion, will begin at 7am on Wednesday the 1st of December 2021 and conclude at 5pm on Thursday the 23rd of December 2021.
- **All orders must be paid for in full, prior to the conclusion of the promotion, including those for account customers, in order to qualify.**
- Zip Pay and Zip Money payment facilities, are not available for this promotion.
- If invoices are not paid in full by the close of business on Thursday the 23rd of December 2021, then their pricing will revert to our normal Retail Price.
- In order to take advantage of the added value benefits being offered as part of the promotion, such as Free Local Deliveries for orders valued over \$1000.00, or Free Warehouse Storage of orders valued over \$1000.00 for up to 3 months, the associated invoice and goods contained therein, **must be:**
  - a. **Paid in full** at the time of placing the order.
  - b. Delivered during the promotional period between the 01/12/2021 and the 23/12/2021, or as soon as possible upon the resumption of normal trading hours, after the Christmas holiday break.
  - c. Collected from the Alstonville Tiles & Floorcoverings Warehouse, no later than Three (3) calendar months from the invoice date, otherwise a weekly warehousing fee of \$55.00/Week will be charged and must be paid, before the goods can be collected.
- The promotion is subject to the availability of the products at the time, and no consideration will be given to extending the offer or waiting for out-of-stock products to become available at a later date, as prices are subject to change without notice.
- **Alstonville Tiles & Floorcoverings, makes no guarantee that the products purchased during the promotion, will be available for collection or delivery, prior to Christmas.** – Orders can be paid at any time leading up to the 23/12/2021, to take advantage of the promotion, however depending on the timing, this may not leave enough time for the goods to be transported to Alstonville, prior to our Christmas closure at 5pm on that day.
- Alstonville Tiles & Floorcoverings will reopen, and normal trading hours will resume, on Monday the 10th of January 2022, along with the resumption of order collections, deliveries, and the receipt of freight from our supply chain network.
- The promotion excludes any product already marked at special or sale prices, remnant, discontinued, clearance, or second quality products.
- **Order cancellations or the return for refund of products purchased as part of the promotion, will not be considered under any circumstances.**
